- Projects requiring recurrent funding for salaries to deliver new clinical services will not be considered, however funding to pilot an initiative may be considered (pending WCHN endorsement)
- The WCH Foundation may discuss with WCHN Executive some conditions of approval. These will be advised when the grant is awarded.
- As part of the award, you will be required to submit project feedback and be willing to participate in social media stories regarding the impact of your grant.
- Grant funding may be awarded up to and including the maximum amount available.
- If your application involves a wall-treatment, mural or artwork, please first speak to the WCH Foundation Arts in Health team (8464 7900) before preparing your application.

1. Staff member / team to complete Grant Application Form. Applicant must obtain Division and Department approval.
2. Completed forms (together with any supporting documentation) to be forwarded by Monday 31st March to WCHN Business Services Coordinator Rose-Mary Hunter via email RoseMary.Hunter@sa.gov.au who will arrange WCHN Executive endorsement.
3. WCHN will forward all applications to the WCH Foundation after endorsement.
4. The WCH Foundation will review all applications to assess suitability and alignment with WCH Foundation goals.
5. The WCH Foundation will notify applicants and signatories of successful / unsuccessful applications (no later than 30th April 2025) and provide final approval forms.
